# **Limited Warranty**

Watkins Manufacturing Corporation ("Watkins") warrants from the date of installation to the original consumer purchaser ("you") the following, when the new Utopia series spa is purchased from an authorized dealer/service provider ("dealer").

# **10 YEAR NO LEAK SHELL WARRANTY**

Watkins warrants the shell of the Utopia spa to be free from manufacturing defects resulting in water loss for ten years.

#### **7 YEAR SHELL SURFACE WARRANTY**

Watkins warrants the acrylic shell surface of the Utopia series spa to be free from defects in material and workmanship for seven years.

#### **5 YEAR NO LEAK PLUMBING WARRANTY**

Watkins warrants the plumbing of the Utopia series spa to be free from leaks caused by defects in material and workmanship for five years. This warranty specifically covers leaks from the wall fittings, jet fittings, internal plumbing, internal glue joints, drains, hoses, and all bonded parts.

#### **5 YEAR COMPONENT WARRANTY**

Watkins warrants the electrical components, pump(s), and other electrical Utopia series spa components to be free from defects in material and workmanship for five years. Some parts, most of which can be replaced without the use of tools, (i.e. filter cartridges, filter lids, spa pillows, and cover locks) are not included in this warranty. Spa covers, and other spa accessories are excluded from this warranty, although they may be covered under other warranties. Please check with your Caldera® spa dealer for details.

# **5 YEAR ENERGYPRO® HEATER WARRANTY**

Watkins warrants the factory-installed EnergyPro heater in the Utopia series spa to be free from defects in material and workmanship for five years. This warranty does not cover commercial or industrial use spas or spas that have been improperly installed.

# 5 YEAR AVANTE™ CABINET WARRANTY

Watkins warrants the Avante spa cabinet to be free from defects in material and workmanship, including cracking, splintering, splitting, rotting for five years. This warranty specifically covers the cabinet's structural integrity, including assembly. Fading and weathering of the cabinet's surface may naturally occur over time and are not considered defects. Refer to your Utopia series spa Owner's Manual for proper care and maintenance instructions.

# 3 YEAR ULTRAMASSEUSE™ SYSTEM WARRANTY

Watkins warrants the factory-installed UltraMasseuse control system on the Utopia series spa to be free from defects in material and workmanship for three years, excluding the pressure switch and cable which are warranted for one year.

# **2 YEAR LED LIGHTING SYSTEM WARRANTY**

Watkins warrants the factory-installed LED light assemblies which consist of all lights within the spa to be free from defects in materials and workmanship for two years.

# **1 YEAR SOUND SYSTEM WARRANTY**

Watkins warrants the factory-installed wireless sound system, which includes the stereo, wireless components, speakers and amplifier, to be free from defects in material and workmanship for one year.

The following applies to all the warranties listed:

# EXTENT OF WARRANTY

This warranty extends only to the original consumer purchaser of the Caldera brand spa when purchased and originally installed within the country of purchase. This warranty begins on the of installation of the spa, but in no event later than one year from the date of purchase. This warranty terminates upon any transfer of ownership, or if the spa is installed or relocated outside the country of purchase by the original consumer purchaser prior to the expiration of the warranty period.

#### WARRANTY PERFORMANCE

To make a claim under this warranty, contact the dealer where you purchased your spa. In the event you are unable to obtain service from your dealer, please write Watkins at 1280 Park Center Drive, Vista, California, 92081, Attn: Customer Service (800) 669-1881 via Department or call or e-mail, customerservice@watkinsmfg.com. You must give Watkins, and/or your dealer written notice of any warranty claim, along with a copy of your original purchase receipt indicating the date of the purchase, within thirty (30) days of the time you discover the claim. Watkins reserves the right to inspect the malfunction or defect on location.

Watkins or its Authorized Service Agent will repair any defects covered by this warranty. Except as described herein, you will not be charged for parts and/or labor necessary to repair the spa for defects covered by this warranty. In some cases, the servicing dealer may charge you a reasonable repairperson travel/service charge that is not covered by this warranty. Please contact your dealer for information regarding any such charges.

#### LIMITATIONS

Except as described above, this warranty does not cover defects or damage due to normal wear and tear, improper installation, alteration without Watkins' prior written consent, accident, acts of God, misuse, abuse, commercial or industrial use, use of an accessory not approved by Watkins, failure to follow Watkins' Pre-Delivery Instructions or Owner's Manual, or repairs made or attempted by anyone other than an authorized representative of Watkins. Alteration includes, but is not limited to, any component or plumbing change, or electrical conversion.
